**The rules and information presented below cover photographs and video intended for use by Foundation Academies publication(s), marketing, newsletters, brochures, view books, promotional items, social media, and other such material. Outside agencies seeking to use photos of FA scholars must obtain separate, specific permission.**

Throughout the school year, there will be times when Foundation Academies (aka: Foundation Academy Charter School, hereinafter "FACS") staff, the media, or other organizations, with the approval of the school principals and CEO, may take photographs of, audio of, video of, or interview students for school-related stories. The rules and information presented below govern photographs and video intended for use by FACS publication(s), marketing, newsletters, brochures, view books, promotional items, social media, and other such material.

As you are aware, there are potential dangers associated with posting personally identifiable information on a website since global access to the Internet does not allow us to control who may access such information. Personally identifiable information would include a student's surname, residential addresses, e-mail address, phone numbers, and locations/times of class trips prior to the trip.

Pursuant to law, FA will not release any personally identifiable information without prior written consent from you as parent or guardian. An example might be a press release about scholar achievement. The law requires that we ask for your permission to use information about and image of your child.
